

# Sabold Elementary School: Title I LEA & School Parent Family Engagement Policy (2023-2024)

Parent feedback is solicited at this meeting for ways in which we can improve our programming. Our parent evenings provide childcare to support meaningful participation by families that have young children and we record the event to provide those that cannot attend the opportunity to take part in the program.</p> <p>Additionally, a survey is emailed directly to all Parents/Guardians of Title I students soliciting further feedback on programming and services. This survey is maintained on the District’s Title I Services website all year. Data from that survey is discussed at an Education Committee meeting scheduled in the Spring of each year where parents, teachers, and administrators are invited to consult on the findings and renew the FEP for the upcoming school year.</p>

Discussions occur which target numerous areas of Title I implementation, including, but not limited to, the planning of parent evenings, conferences, program updates, allocation of resources, and program materials.</p>

Each year, monies are set aside to provide additional resources for families to support their child at home. This year, families requested calculators for math support and updated grade-level readers for literacy support.</p>

In addition, data is shared related to the academic achievement of students in these program to better inform decision making. Because the district uses it's Ready to Learn state grant on CSR (as well as Title II), the District provides this information to canvas feedback on programming decision-making.</p>
<p>The policy states how the LEA conducts, with the meaningful involvement of parents and family members, an annual evaluation of the content and the effectiveness of the parent and family engagement policy in improving the academic quality of all schools.</p>	<p>The Parents/Guardians of the Sabold Community are what make this school one of the exemplars in the state of Pennsylvania in student performance, achievement, and engagement. A Blue Ribbon school, Sabold utilizes the previously mentioned opportunities to engage families resulting in a constant state of continuous improvement. Professional development on cultural awareness, educating food insecure students, representation in curriculum all stem from feedback by parents in building meetings/events, at parent conferences, on our Title I survey, and during our committee meetings. Sabold continues to achieve at the top of the state because of our ability to listen to our families.</p>
